## Nashua City Council Meeting Minutes Welcome Center January 29, 2018

The Nashua City Council met in regular session January 28, 2018 at the Welcome Center. The first order of business was the Oaths of Office for newly elected council members Angelina Dietz and Harold Kelleher III. The meeting was called to order at 7:00 pm with Mayor Clinton Betsinger presiding. Council members present were Thomas Johnson, Angelina Dietz, Harold Kelleher III, and Scott Cerwinske. Council member Ryan Jung was absent. The following city employees were in attendance: City Clerk Rhonda Dean, Police Chief Travis Marvin, and Sewer Department Superintendent Nick Henningsen. Fourteen (14) guests were in attendance.

The mayor called for citizen/public comments. A citizen asked for an alternate information option for water shut offs due to a main break other than social media. The council will review options for informing regarding water shut offs.

Council Member Cerwinske moved to approve the agenda with one correction, Dietz seconded. Motion carried. Council member Dietz moved to approve the minutes of the December 18, 2017 meeting. Cerwinske seconded. Motion carried. Council Member Cerwinske moved to approve the consent calendar of payment of claims (12-28-17 to 1-29-17) and building permits. Kelleher seconded. Motion carried.

Consider and approval of Resolution 18-01, APPROVING EXTENSION OF CEDAR DEVELOPMENT TIF AREA. Motion by Dietz to approve the extension, seconded by Cerwinske. Motion carried unanimously.

Consider and approval of Resolution 18-02, APPOINTING THOMAS JOHNSON AS FIRE CHIEF FOR 2018. Motion by Dietz to approve appointment of Johnson as Fire Chief. Seconded by Kelleher. Motion carried with Johnson abstaining.

Consider and approval of Resolution 18-03, AUTHORIZING BANK SIGNATURES AT FIRST STATE BANK. Motion by Cerwinske to authorize signatures at First State Bank. Seconded by Dietz. Motion carried.

Consider and approval of Resolution 18-04, AUTHORIZING BANK SIGNATURES AT LINCOLN SAVINGS BANK. Motion by Cerwinske to authorize signatures at Lincoln Savings Bank. Seconded by Kelleher. Motion carried.

Consider and approval of Resolution 18-05, APPOINTING RHONDA DEAN AS CITY CLERK, DAN ZWANZIGER AS STREET DEPARTMENT HEAD, JEFF SMITH AS WATER DEPARTMENT HEAD FOR 2018 & 2019. Motion by Dietz to approve the appointments. Seconded by Johnson. Motion carried

Consider and approval of Resolution 18-06, AUTHORIZING THE HIRE OF A FULL TIME POLICE OFFICER FOR THE CITY OF NASHUA. Motion by Dietz to authorize hire of full time police officer. Seconded by Cerwinske. Motion carried with one no vote by Johnson.

Fire Chief Thomas Johnson was sworn into office as the Fire Chief of the Nashua Fire Department for 2018.

City Clerk Dean reported the City received a grant for \$4000 from the New Hampton Hotel-Motel Tax Foundation for attractions map and park kiosks. The Park Board will handle this project as Spring approaches. The State Auditor's office was here for the FY2017 audit the week of January 8. There will be recommendations. Some of those recommendations have been implemented already. As soon as the final report is in, council will receive copies. Monthly staff meetings for city staff will begin February 6 and run the 1<sup>st</sup> Tuesday of each month. This will be an opportunity for staff to communicate and check-in with department projects as well as review where they are with their budgets and spending for the year.

Police Chief Marvin shared that radios will be converted to digital in Chickasaw County by mid February. PD purchased digital radios at a reduced rate and was able to install them saving money over having someone install the radios.

Sewer Superintendent Henningsen shared the water treatment plant is required by the DNR to purchase a sampler for testing. It must be installed by mid March and start sampling by then. Henningsen also requested permission to have specific sewer lines optically viewed in order to determine what is causing sewer back up in specific parts of town. In one case, there is an insurance claim pending. Council Person Johnson moved to allow the purchase of the sampler and the camera service for the sewer department. Cerwinske seconded. Motion carried. Henningsen gave an update on the thawing process for the clarifiers. The domes have been built and installed which has heated up the one clarifier. The other clarifier is still frozen, but heaters have been installed to warm it.

The Library report was included in council packets. It outlined upcoming events and funding from the county for FY2019.

Discussion and approval of appointment of Chickasaw County EMS/911 Board Representative. Dietz moved to appoint Cerwinske to the Chickasaw County EMS/911 Board. Johnson seconded. Motion carried.

Discussion and approve of appointment of Area Development Corporation Board representative Angie Dietz. Johnson moved to appoint Dietz. Cerwinske seconded. Motion carried.

Discussion and approval of moving Nashua Police Department out of Council Chamber room and City Council Meetings return to City Hall. Cerwinske moved to move the Nashua Police department and return to City Hall for council meetings. Kelleher seconded. Motion carried.

Discussion and approval to reinstate Dollar General charge account for city employees. Dietz moved to reinstate charge account at Dollar General. Johnson seconded. Motion carried.

Discussion and approval regarding Williams and Company review of FY2017. Dietz moved to discontinue review by Williams and Company. Seconded by Cerwinske. Motion carried.

Mayor Betsinger wanted to thank the citizens of Nashua for their support in this transition time.

Cerwinske moved to adjourn the meeting. Dietz seconded. Motion carried to adjourn at 7:45 pm.
